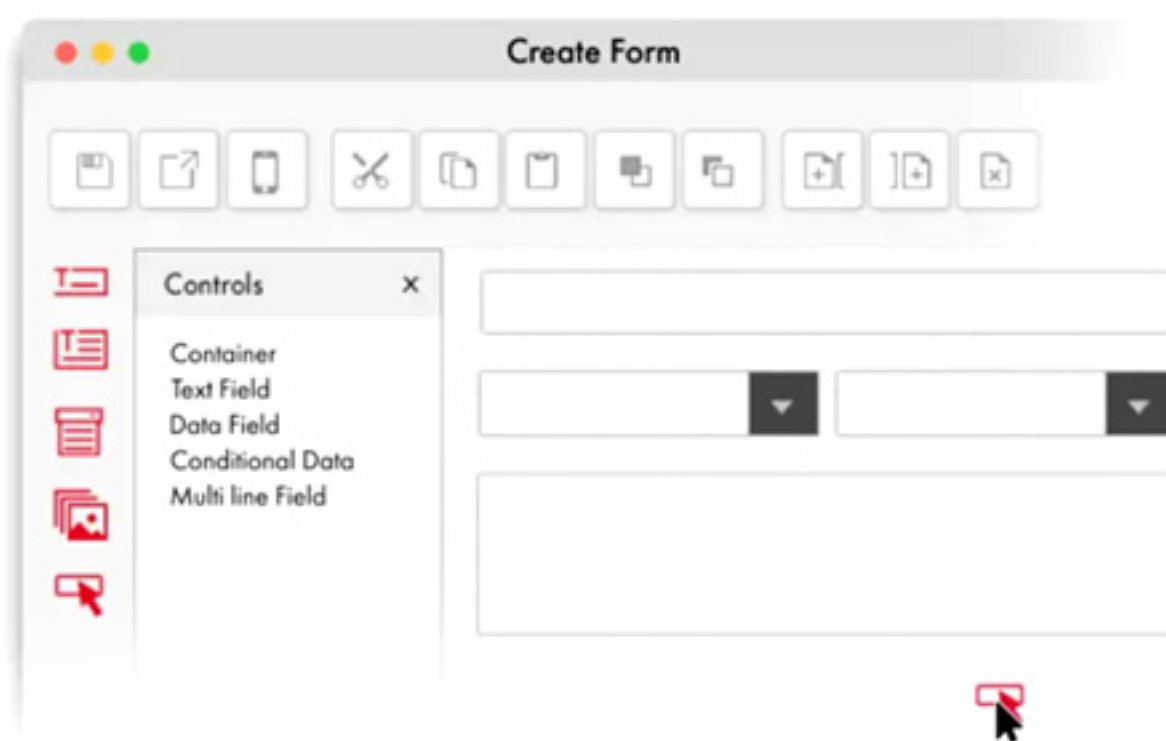

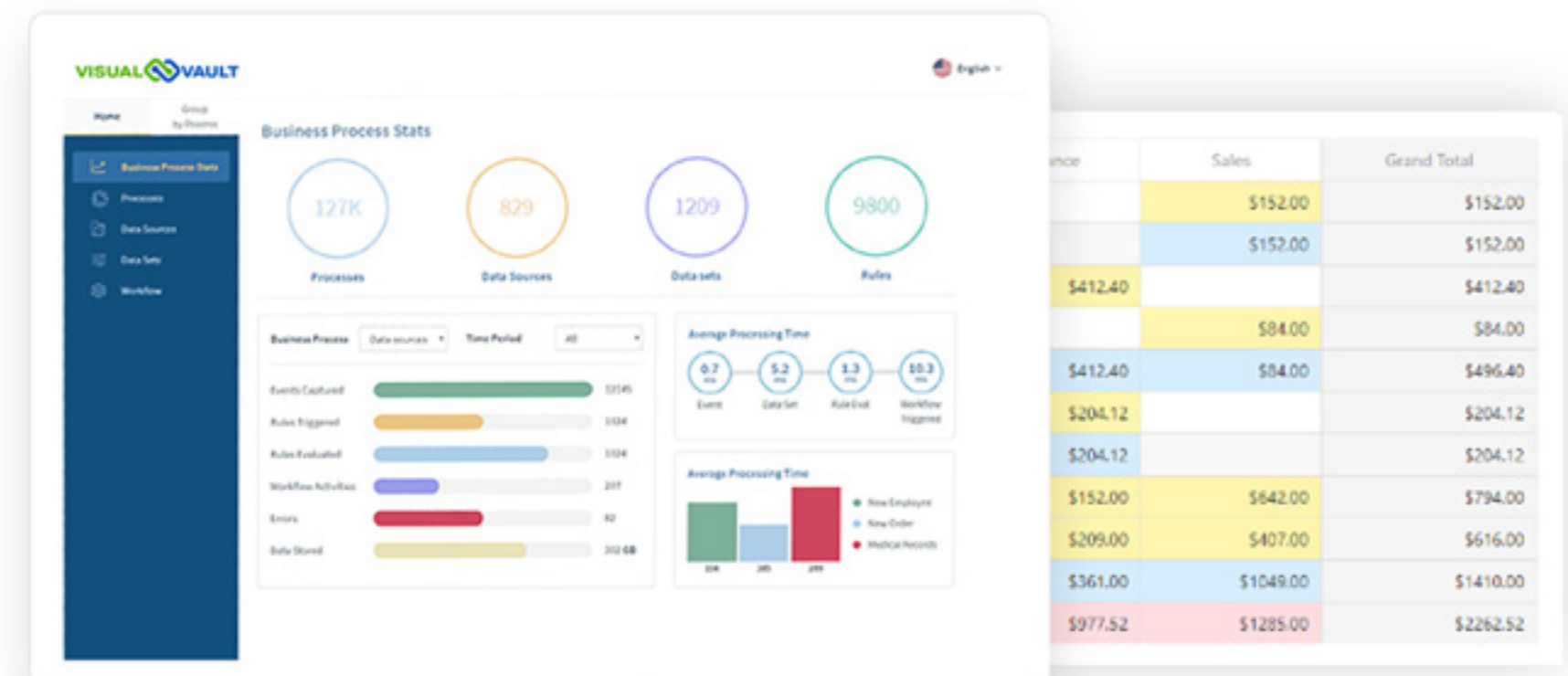
iForms

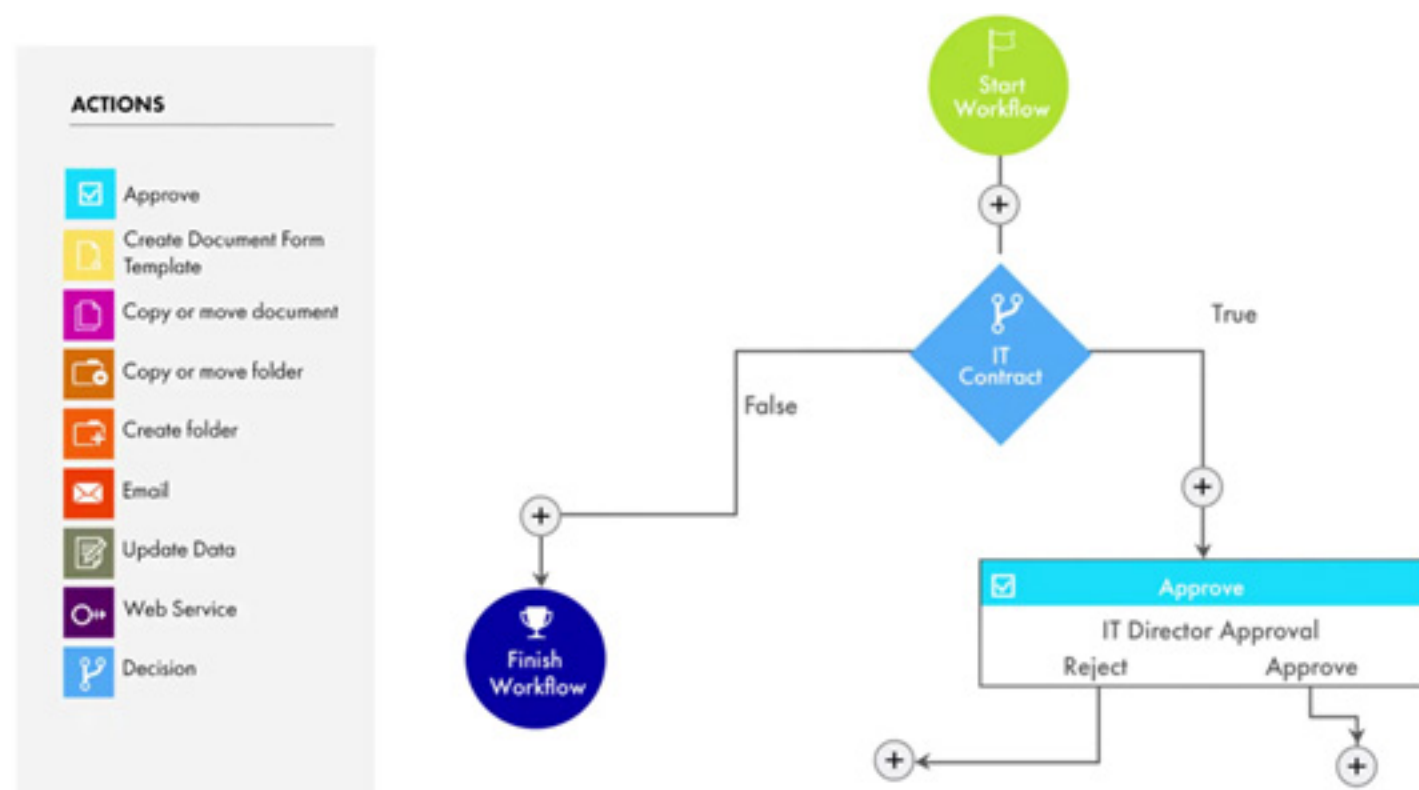

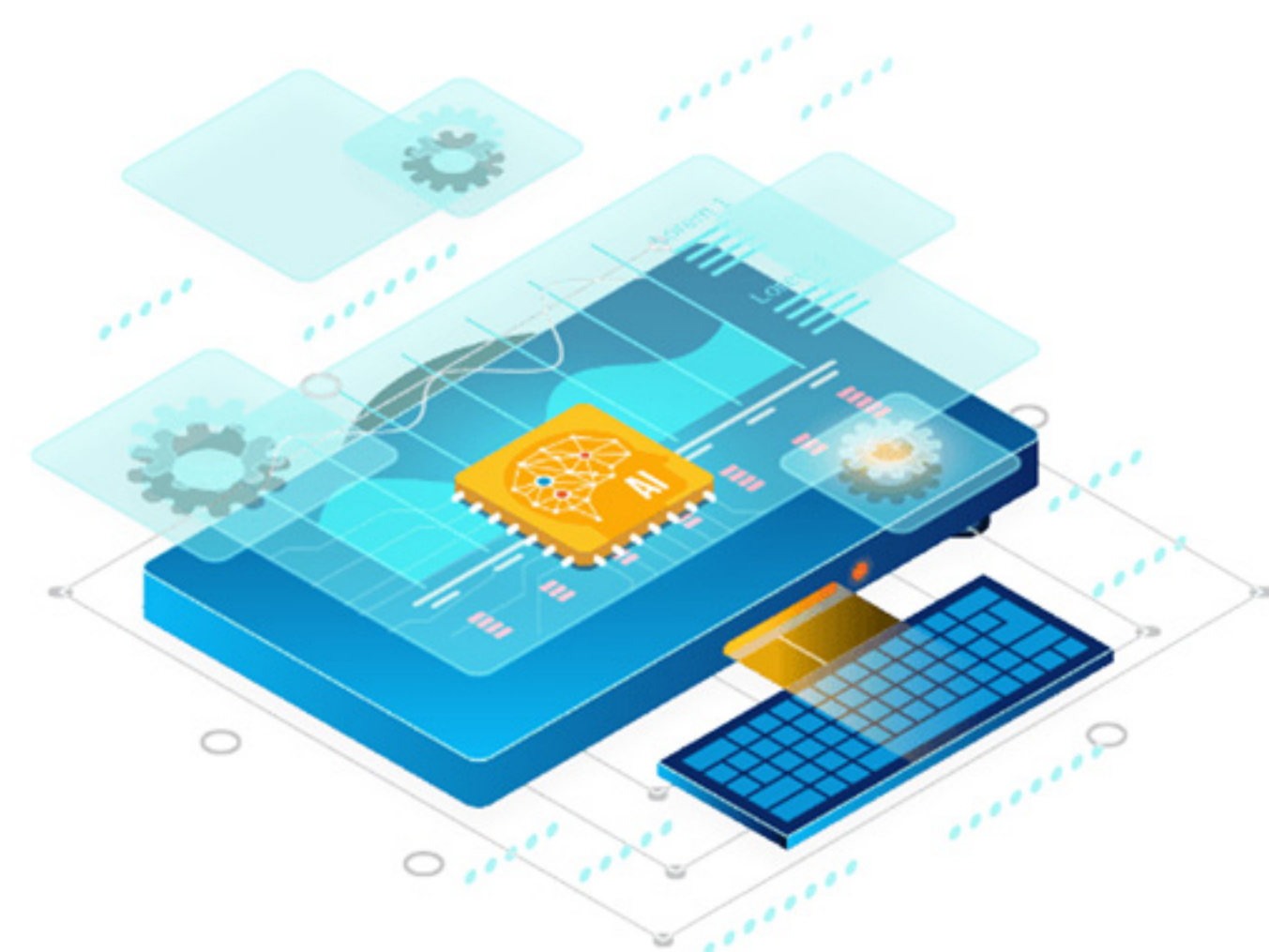
