Medical Facility Relocation Planning & Coordination

- Detailed planning with each department
- Web-based software platform with specific department move plan templates

- Move plans to show compliance with health department requirements
- Integration of all support departments into the move plan schedule
- Vendor coordination for equipment that needs servicing and vendor support for its relocation

Decommissioning Services

- Donate, sell, recycle, refurbish, auction and dispose (environmentally-responsible methods)
- Re-purposing of equipment through a web-based platform to order and track
- Terminal cleaning services to prepare old facility for decommissioning
- State mandated certifications for decommissioning with all documentation
- Removal of all items for decommissioning such as batteries, sanitizers, biohazards etc., with process control through an online software platform
